Mike Mead presented plaques to the TBRA Committee, which were received with thanks.

Frank Mackzum introduced Gerard Bisceglia, CEO of USACycling. Mr. Bisceglia explained the proposed agreements which would be entered into with local Associations (e.g. TBRA); he explained what the Associations would be expected to do and what money they would receive from USACycling. Mr. Bisceglia explained it would be entirely up to the Associations as to how this money would

be spent, for instance the Texas Association is planning to use the money to buy Licenses for Junior riders. Mr. Bisceglia then went on to explain that this year's Rule Book would only go to certain people in hard copy format, although copies could be downloaded from the Web. He explained USACycling was in the process of updating the Web site and that eventually everything would be available on line – License applications, Permits, Results etc. He also said that with NORBA One day Licenses the Local Association would be able to designate if this was to be available for beginners only. He confirmed that this year there would be no refunds for sending results to USACycling, but that it was possible there would be grants to local Associations later if they brought in Juniors.

A Motion by Todd Nordmeyer to have TBRA Board look at agreements etc was tabled for New Business.

Frank Mackzum thanked Mr. Bisceglia for coming and also for putting something back into the sport locally for the first time.

George Heagerty elaborated on the Local Association Agreements, saying someone in TBRA (probably the appropriate V.P.) should be responsible for permitting, assigning Chief Referees, upgrading to Category 2 (Road) and Expert (Mountain Bike), and receiving copies of post event reports. He explained that if the Local Association undertook to be responsible for NORBA, then higher insurance fees would be charged in order to pay the Local Association.

Frank Mackzum thanked Mr. Heagerty for this information and clarification.

It was agreed that the \$50.00 trailer fee to be paid by Promoters should be added to TBRA race fees and the refund made once the trailer had been checked after its return.

Anyone who would be towing the TBRA trailer must be_insured. A motion was made that Board Member Counsel draw up indemnity form to be signed by whoever is using the trailer.

Rules:

The following changes were agreed for the BAR competitions:

Starting in 2003 the racing year will end October 31st and the new year will start November 1st for the purpose of BAR points.

Rules: (TORBAR)

The following changes were agreed for the BAR competition.

Under TORBAR categories for men, the following shall be added:

Pro/Semi Pro Category.

Under "Eligibility of Participants" the following shall be added:

"Riders not wishing to become Club Members shall be allowed to take out individual non-voting TBRA Membership for \$15.00 per year and shall be eligible for the appropriate Championship Jersey. The Individual Member's points will accumulate from the date of membership. All other appropriate TBRA/TORBAR Rules shall apply."

2003 Race Schedule

A draft schedule was distributed and agreed. Information to be published on the Website with additional races to be added as approved.

The date for the 2003 Championship Dinner and Annual General Meeting was also agreed. These will take place on the weekend of November 8th/9th, 2003.

Any Other Business

It was agreed TBRA will be responsible for sending out information regarding bad checks to Promoter of the following race so that they have this information to hand. USAC to be asked if this can be dealt with by them.

It was agreed that Frank Mackzum would make out a Promoter check list to send to anyone wishing to put on a race.

A motion was considered that TBRA look for a Corporate Sponsor for a prize list and that this money be given to the points winner, regardless of whether the winner is eligible for the TBRA Jersey. It was decided this matter would be looked into before the next AGM. and should be voted on at that time.

It was requested by Greg Johnson that something be done with the Website to make it more interactive and current, possibly with a weekly update, message board etc. He requested that people e-mail in suggestions. It was agreed that if this would be too time-consuming for Vicki Mackzum (current Webmaster) then the Website should be contracted out.

A Motion was made to have the TBRA Board look at USACycling/Local Association Agreements etc and act on these in the best interests of TBRA.
