# **Opening Remarks:**

The President called the meeting called to order and welcomed all in attendance in person or via conference call.

A plan for a promoter meeting/summit was announced. Tentative dates for this meeting are January 10-11; 10-5 Sat, 8-12 Sun. Details TBA. Summit will likely include training for Race Manager software.

#### Financial status:

Todd Nordmeyer presented the Treasurer's report and 2008 TBRA budget. Highlighted cash balance of approximately \$21,000. Report is up to date excluding purchase of jerseys which will be approximately \$2,000. Some promoters have not paid 2008 event fees; emails will come from Todd asking for payment.

Banquet did not make money; expenses were slightly above budget. Rebates from USAC license sales were close to budget. Outlay for race manager included monthly license fee and consultant fee. No one took advantage of Jr/U23 Grants. Increased utilization of grants was encouraged. Income from event fees is slightly higher than budgeted though was down from 2007 as a result of reduction to \$1 event fee. The BikeReg.com rebate is expected to arrive in December. Checks of \$.25 per rider will be dispersed soon after the check arrives.

# 2009 Road and Mountain Bike Racing Schedules

Tim Hall suggested several options for promoters in order to improve quality of events. Suggestions included co-promoting as alternative to small stand-alone events, striving toward full weekends to get good turnouts, and avoiding conflicting dates in different parts of the state.

#### Announcements:

- In the Road Series, the 2009 State RR/Crit will not be at the same location/event as 2008. Promoters were encouraged to contact Tim if interested. A bid process will be announced. Tim suggested that the 2009 TT will be in same location for the short term.
- Deadlines for Flyers/Timing of event announcements will be more strictly enforced this year.

- Efforts will be made to create consistency in flyers/registration process.
- Promotion of event must be held off until the event has been permitted by USAC.
- Additional items to be discussed on forums and during permit process are the possibility to hold events specific to certain categories [i.e. Masters/Jrs, Women's/Jrs, etc], rotation of state championship events throughout different regions of the state, Overlap of MTB/RR dates, and impact of economic issues on racer's travel tendencies.

#### Event scheduling:

Road dates and MTB dates were assigned according to requests from promoters in attendance. Stuart Lamp provided feedback regarding National and Regional dates. Preliminary calendar to be posted on <a href="https://www.tbra.org">www.tbra.org</a>.

#### Cross:

There was a discussion of allowing a competing cross races in same weekend. Numbers on affected events were down somewhat compared to non-conflicting events.

Areas for improvement in 2009 were identified by Dan Werle. Suggestions include better regional communication, improved communication with competing state series, revisit issue of stratification of points series, or potentially reduce number of TBRA races. Additional items include the end of 2 yr commitment to waive TBRA fee for cyclocross races.

Board will discuss options, and incoming Cyclocross Director will be involved in these decisions.

# Overview of Race Manager - Bill Parsons

Bill Parsons provided a preview of the Race Manager software. Software agreement finalized this year; to be available to promoters in 2009. Comments were provided by software developer.

Todd proposed that fee for Race Manager operator to be paid for by TBRA for approximately one year. Operator potentially may be paid a rate similar to that of an official.
